

Instructions > Gear Bucket

The PMI Gear Bucket can hold all of your gear and literally stand up to the test. Plastic reinforced stays keep the bucket upright while stacking your rope inside. Store rope, gloves, pulleys, cord and even snacks in the mesh pockets with velcro closures surrounding the outside of the bucket.

USE GUIDELINES

Remove the Bucket from service and destroy it if it does not pass inspection or if there is any doubt about its serviceability. Reasons for retirement may include, but are not limited to the following:

- Exposure to heat, chemical or hazardous conditions.
- Fabric shows damage, abrasion, tearing, or excessive wear.
- The stitching is cut, torn or excessively worn.
- If damage is evident that may effect the quality of the gear that is stored in the Bucket.

MAINTENANCE AND CARE

Inspect Gear Bucket upon receipt and before each use to ensure stitching is adequate. Maintain records to ensure safe use of this product, and by applying the following use guidelines:

- Beware of possible abrasion where Bucket come into contact with hard surfaces.
- Bucket may be cleaned with water or a mild solution of non-detergent cleanser.
- Store in a clean, cool, dry environment. Always be sure the Bucket is completely dry before storing.
- Always completely dry gear that is kept in the Bucket before storing.
